

Privacy Policy

Intercorp, Inc. (hereinafter referred to as “Intercorp”), is a member of the financial services industry. As such, our agency is subject to federal and state privacy laws regarding the collection and exchange of your information.

Our Privacy Principles

- We do not sell your personal information to anyone.
- We restrict access to your personal information to those employees who must use that information to provide our products or services to you.
- We maintain physical, electronic, and procedural safeguards to protect your personal information.
- We afford prospective and former customers the same protections as existing customers with respect to the use of personal information.
- We only share information necessary to provide you with an accurate quote or to meet your transaction needs.

Information Provided by You

Intercorp collects information about our customers that is necessary to provide those services usual and customary to independent insurance agents. We collect this information from the following sources:

- Applications, surveys, or other forms provided by you by telephone, fax, or online. This information may include but is not limited to your name, social security number, address and date of birth.
- Information concerning your transactions with us including—but not limited to—your claims and payment history.
- Consumer Reports and State information which may be received from consumer-reporting agencies or a state agency. This information may include—but is not limited to—your driving record, claims history reports, or insurance score reports. We will disclose Consumer Reports and State information only as necessary to quote or service your insurance and as permitted or required by law. We will only share information as necessary to transact insurance with our insurance carrier.

Nonconfidential Information Submitted by You

Any general or non-personal information provided by you, including but not limited to feedback, questions, comments or suggestions or the like, shall be deemed to be non-confidential.

Parties to Whom We May Disclose Information

We only disclose your personal information as necessary where permitted or required by law. These situations include but are not limited to the following:

- Information that is necessary to service or process the insurance needs of our clients, in a manner that is consistent with usual and customary services provided by an independent agent. Such services and processes include but are not limited to underwriting, placement, rating, and providing quotes for insurance that is requested through our agency.
- Information that is necessary to resolve client disputes or inquiries.
- Information required by individual or entities who are assessing our legal compliance or where required by law.
- Information that is necessary to protect against or prevent fraud, unauthorized transactions, claims or other liabilities.

Online Data

For each visitor to our web page, our web server automatically recognizes only the domain name, names and the email address (where possible). We collect only:

- The domain name.
- The email addresses of those who communicate with us via email.
- Aggregate information on what pages web users visit.
- Information volunteered by the web user, such as quote requests, survey information and/or site registrations.

The online data that we collect is not shared with other organizations for commercial purposes. All information that we collect will be used to:

- Provide insurance proposals requested by users, based on the information they have supplied.
- Maintain communication with current or prospective customers in order to provide information on new products, services, or upcoming events.
- Improve the content of our web page and notify users about updates to our site.
